# 11. Update from other groups:

### Village Hall

A few problems with the roof. Guttering to be put on correctly. Now looking to extending the other side. Plans to be drawn up – long term plan. Bar – up to 12 uses of the bar in the year - £21 to purchase a licence. Putting the onus on people who hire the hall. Anyone who wants to hire the hall needs written permission from the Village Hall committee stating a licence will be required. The control element is held by the Village Hall. This will now be written in the conditions. (Alcohol cannot be used to raise funds). A number of new bookings have been taken. Equipment now held for 'indoor Bowls'. Letters to be sent to all local bowls groups.

#### **PCC**

Agreed removal of half the pews from the Church – passed unanimously. Open public information evening meeting to be held in the Autumn to see proposals, plans together with a presentation. Consulted with a Church specialist and are going with his plans. The community will be kept informed and consulted.

### PC

Parish Clerk is showing promise and has now taken on another Parish Clerk role.

Traffic and speeding – meeting to be held with Head of Highways. Possibility of a reduction in speed from 50 to 40 to 30. Highways agency see the route through Church Minshull as a 'main artery' Meeting with Chris Shields, Highways on 10 August. Questions were raised as to why police monitor speed in Worleston and not Church Minshull.
