MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON THE 17th of MARCH 2014.

Present: Clirs D Wallis, K Bannon, L Bannon, J Stockdale, B. Charlesworth and L Hassall- Clerk.

14.03.01 Apologies for absence –

Apologies received from M Carss and C Challoner. RESLOVED.

That apologies received are acceptable as a valid reason for absence under s.85 of the Local Government Act 1972.

14.03.02 Declaration of interest in items on the agenda – None.

14.03.03 Public participation- None present.

14.03.04 Borough councillor's report -

Clir Jones reported on the following issues.

<u>Housing- Cllr Jones asked the councillors to consider setting a number for new housing if appropriate. Including assessing the need for affordable housing, and impact on existing infrastructure. KB discussed the key themes from the plan, which included affordable housing and rural poverty, specifically isolation and access to services. The matter was discussed further.</u>

<u>Traffic calming- BC</u> joined the meeting. Cllr Jones asked the council their opinions on permanent traffic light on the bridge, highlighting the potential problems, such as getting power to the area. The councillors discussed the matter including a recent traffic lights battery failure on Canal Bridge. LB stated that if lights were made permanent, where traffic would stop would need careful consideration to allow residents to access their properties. This matter was discussed.

Home Park- Clir Jones discussed speed limits in this area at the turn off to Paradise Lane, which is 60mph. The councillors discussed the matter, including signs. DW told the meeting that in a meeting with John Dwyer he advised that the speed limits are within the power of the borough council as the decision maker. Clir Jones provided examples of other areas dealing with similar community issues, and stated that the police will dictate the speed limits and can only be changed with police support. Clir Jones stated that if the parish council were to consider more housing over 14, then there has to be an affordable element of 30%, which can include key worker or policeperson under s.106 of the Town and Country Planning Act 1990, to help mitigate the impact. LB asked if one of the element is a requirement to live, work or play with a specific area on a specific building. Clir Jones stated this could apply to rented property. Clir Jones asked about the need for this type of housing. KB highlighted the issues. Clir Jones advised that the parish council would have to survey the community.

LB asked for clarity on the road sign speed issue. Cllr Jones confirmed that signs can be put up, such as '20 is plenty', but the police cannot enforce without agreement. LB asked Cllr Jones to direct the residents of Home Park to the Parish Councillors so that councillors have more involvement and information on the issues they are experiencing. Cllr Jones agreed to do this.

<u>HS2</u>.- Cllr Jones advised that at present HS2 is not agreed, but there is a possibility that the West coast line by the Verdin Arms will be higher to gain speed.

<u>Geothermic energy</u>- Cheshire East are continuing to work on this and will be announced soon.

<u>Local plan.</u>-The local plan has been passed and Cllr Jones discussed the five year housing supply for the area.

14.03.05 Minutes of the last meeting- JANUARY 2014

14.03.06 Matters arising from the minutes and action points.

Best kept village. The clerk presented correspondence received regarding this issue.

Litter picking. LB raised the issue of fly tipping.

That LB will send a list of areas affected to the clerk, who will then contact Cheshire East to request clearance of waste.

Action points.

Heavy vehicles- JS asked about the heavy vehicles still coming through the village. The matter was discussed. Cllr Jones suggested writing to the company, asking them not to use the route.

VAT -The Clerk advised that the VAT return has been completed and sent, and that the next return is prepared and just awaiting final invoices for the year end.

14.03.07 Reports from meetings:

Police cluster meeting- No report, next meeting April.

<u>Canals and rivers trust update.</u> DW advised that he has received an email CRT, saying that they will be carrying out the works on the access on the 3rd,4th and contingently 5th of April. The issue of adoption was discussed. CRT have asked for signs to be laminated detailing the dates to inform the public. LB will complete this and forward to DW. LB reported that the moored boat has been removed.

<u>Village Hall.</u> JS reported that the hall has broken even, with a small raise in income. However, they have lost a regular hirer. The issue was discussed including fund raising. JS reported that the committee are looking into a Lottery grant for a hub and replacement of the store room. The committee will look into a WREN grant for the works and work with the Vision group.

14.03.08 Progress on a strategic vision for the community.

<u>Community plan.</u> KB provided the members with the draft plan. The group plan to meet next week.

14.03.09 Website.

LB reported that local news has dropped in volume and the news on the canal works will be posted into the site. JS asked about mobile library dates on website. This will also be updated.

14.03.10 Parish compact update.

Clerk advised that the compact will now be administered through Streetscape for the amount of £1,150 which is subject to review and will be paid into the Parish account.

14.03.11 Insurance renewal.

Clerk advised that the renewal will be sent out at the end of May, and she has contact the provider who estimate the cost to be £144.56, the clerk asked members if they are happy to renew or prefer to research of the market.
