22/015 APOLOGIES FOR ABSENCE

22/015.1 Cllrs Schiller and Smith.

22/016 DECLARATIONS OF INTEREST

22/016.1 Cllr Groos declared an interest in planning application 22/1464N.

22/017 MINUTES OF THE ANNUAL MEETING HELD ON 24 MAY 2022

22/017.1 RESOLVED – that the minutes of the meeting be approved as a true and correct record.

22/018 PUBLIC PARTICIPATION

- 22/018.1 A Member of the public raised concerns regarding the problems caused by the volume of traffic through the village which had been exacerbated by the closure of Middlewich Road in Leighton and sought information on the Council's strategy to attempt to improve the situation.
- 22/018.2 Cllr Lewis advised that the Parish Council had tried many times to engage with Cheshire East highways, local MPs and Government ministers on this topic but mostly to no avail. In a further attempt to progress the situation, Cllr Lewis had written to the Chair of the Cheshire East Council Highways and Transportation Committee to urge an urgent review of the highway issues in the Parish. The Parish Council was also developing an addendum to the Neighbourhood Development Plan which would identify a longer-term solution.
- 22/018.3 The Chair of Cholmondeston and Wettenhall Parish Council referred to a forthcoming meeting with the Police and Crime Commissioner to discuss speeding, HGVs and rural crime/flytipping. This would be held on 29 September, at St David's Church, Wettenhall, commencing at 7.00pm, to which there was an open invitation.

22/019 FLOODING/HIGHWAYS

22/019.1 Councillors expressed concern at the lack of hedge/foliage trimming across the village as many of the road signs were now obscured. It was recommended that any instances be logged on the Cheshire East Council highways portal and the Clerk was asked to write to three landowners where this was of particular concern.

22/020 HS2

- 22/020.1 Following the recent meeting with HS2 representatives, Councillors discussed the commitment that HS2 vehicles would not travel through the village. Further clarity would be sought on how this would be enforced.
- 22/020.2 The Clerk referred to an invitation to the Cheshire East Council HS2 Local Liaison Meeting which would be Tuesday 19 July at 5pm. It was agreed that an article be placed on the website inviting residents to submit any questions they have on HS2.

22/021 VILLAGE HALL REDEVELOPMENT

- 22/021.1 Cllr Boote provided an update on progress regarding the redevelopment of the Village Hall. The initial ecology report had identified the need for two further reports, which were being progressed.
- 22/021.2 It had been confirmed that the land was owned by the Village Hall Trustees, with the exception of a small area which was owned by Cheshire East Council.

An information article would be included in the next Insight magazine and a meeting with the Cheshire East Council Net Zero representative would be held in early September.

22/024.2 Councillors expressed concern at the reduction in the local bus service as this would be counterproductive to reducing people's carbon footprints.
