AOB – LB met with Stephen Jones – Public Rights of Way Unit, on 12.02.15 to discuss the deterioration of the footpaths in Bluebell Wood. Changes were proposed:- topography; handrails to the bridge; drainage to alleviate waterlogged areas and the boardwalk. The area is more accessible from Eardswick Hall, Minshull Vernon. LB to contact Mr and Mrs Ford of Eardswick Hall to request permission for access.

LB reported the budget for works is currently exhausted; however it is annually refreshed on 1st April. The works would commence towards the end of May/beginning of June 2015.

LB reported the registration of Church Minshull in "The Best Kept Village Competition". 5 categories have been entered, including the Cheshire Pride Awards. The entry fee of £28 was paid my LB.

A quote has been received from Rebekah Fuller to supply signage for the Towpath Walk and the Bluebell Walk.

It was reported that stiles are broken and the footpaths require work.

Reaseheath have designed a bench and picnic table. They will be ready in May. A photograph to note the work of the students in the production of the bench and table will be taken in due course.

16.03.08 Housing Survey

DW attended the recent open day at CE "Meet the Developer" on 11th March 2015. There were approximately 50 attendees. Workshops and seminars were offered covering Neighbourhood Plans and Local Housing Survey. The seminars gave the opportunity to meet developers such as Archway and Taylor Wimpey.

DW reported that the open day was interesting which gave rise to a discussion of the subject of The Neighbourhood Plan. DW defines the remit of a Neighbourhood Plan. DW reported that £8,000 was available as a grant to prepare for the consultative phase and is paid by CE. A further £8,000 was available to take the Neighbourhood Plan process to referendum.

if we collaborate.
