Members should note that there has been a steady increase in balances since 2005. This was reversed in 2009-10, when balances fell by £1,000 (due to expenditure on grant funding to the Village Hall and roadsigns). In 2010-11 balances increased by approximately £450, and 2011-12 is likely to see a balanced outcome. The level of balances has been queried in the past by the District Auditor, who generally regard balances above a year's precept/expenditure as excessive. Although there has been no specific reference in recent years, members may feel it appropriate to consider the level of balances in setting this year's precept. In the medium to long-term a precept of £2,500 to £2,700 is probably necessary, but the level of balances would certainly allow a reduction to, say, £2,000 in each of the next four years.
