19/84.1 Cllr Parton declared a personal interest in the item regarding flooding.

# 19/85 PUBLIC PARTICIPATION

19/85.1 Flooding

Members of the public attended the meeting and provided details of the flooding which had occurred on a number of occasions in the year. This had been particularly bad in late October. There were issues with the River Weaver and the run-off from fields.

19/85.2 It was agreed that the Chairman would visit the properties concerned and liaise with the Borough Council and Environment Agency. Cllr Parton agreed to undertake a survey of the gullies in the village. The Council would also consider the provision of sandbags and undertaking a drain survey if necessary.

- 19/89.2 Councillors discussed the provision of footpaths into the village and the Clerk would liaise with the Borough Council regarding any funding availability.

## 19/90 NEIGHBOURHOOD PLAN

19/90.1 The Independent Examiner had reviewed the Plan and it was expected that the Referendum to consider the formal adoption of the Plan would be held early in 2020.

#### **19/91 WEBSITE**

- 19/91.1 Cllr Schiller provided an update on the provision and maintenance of the website. The contract with the current host was due to expire however they had provided the Council with additional time in order to consider a number of options. With regards to maintenance, it was suggested that the Council enters into a contract with the current webmaster and a monthly fee be agreed.
- 19/91.2 Councillors suggested a monthly payment of £50 to commence from 01 December 2019. Cllr Schiller would liaise with the webmaster on this and also prepare a specification of the website requirements to support the Council in deciding the future hosting of the website.
