21/028 MINUTES OF THE MEETING HELD ON 06 JULY 2021

21/028.1 RESOLVED – that the minutes of the meeting be approved and signed by the Chairman as a true and correct record.

21/029 PUBLIC SPEAKING

21/029.1 A member of the public spoke on Planning Applications 21/4667N and 21/4668N.

21/030 CO-OPTION

21/030.1 The Clerk advised that there had been no requests for co-option onto the Council to fill the existing vacancy. It was noted that there was no time limit on filling the vacancy therefore this would remain open.

21/031 BOROUGH COUNCILLOR'S REPORT

21/031.1 Borough Cllr Pochin referred to the consultation for the Community Governance Review, the commencement of the Goto Rural Bus Service and that the Crewe Town Centre redevelopment project had gained planning permission.

21/032 FLOODING

- 21/032.1 Cllr Lewis referred to the response from the Department for Environment, Food & Rural Affairs (Defra) which advised that Eel Brook was the responsibility of the Borough Council. There had been no mention of the River Weaver in the response, so a reminder had been sent.
- 21/032.2 Councillors expressed frustration at the lack of progress despite all of the efforts made to date. Further correspondence would be sent to Defra and Edward Timpson MP. Borough Cllr Pochin would also raise the issue again with the Borough Council.

21/033 VILLAGE HALL REDEVELOPMENT

- 21/033.1 Cllr Boote advised that the next stage was for the Committee to meet with the architect and the planning authority. There was uncertainty as to whether the Borough Council was currently providing pre-application advice. However, the views of the planning authority at an early stage were essential for the project to progress.
- 21/033.2 With regards funding for the architect, it was proposed that this would be split equally between the Village Hall Committee and the Parish Council. It was noted that the Parish Council had earmarked £3,000 for the project.

21/034 WILDLIFE AREA

21/034.1 There had been little progress on this and Councillors considered that there could have been more support from the Wildlife Trust following the meeting, although noted that the new grant system had not yet been finalised.
