A. DISCLOSABLE PECUNIARY INTERESTS

If you fail to do so, and then participate (speak or vote or both) at a Council or committee meeting, you may be committing a criminal offence.

I must also make the appropriate declaration at that time and take appropriate sction.

(i) omit any information that should be included in this Notice;

(ii) give false or misleading information; or (iii) neglect to keep my register entries and/or declarations up to date.
