25/028 HIGHWAYS ISSUES

Concern was expressed regarding the condition of FP4 which was no longer passable. Although Cheshire East Council had suggested that this might be closed permanently, the Parish Council had objected to this.

Councillors noted the closure of Over Road whilst the bridge was being repaired.

Cllr Kynaston joined the meeting at this point.

25/029 VILLAGE IMPROVEMENTS

Further to the support indicated at the last meeting, Cllr Smith confirmed that permission had been granted to provide a defibrillator at Home Farm Park. Cllr Lewis advised that he would share the training literature and a training date would be provided, in due course.

RESOLVED – that the Council hires a defibrillator for provision at Home Farm Park.

25/030 BIODIVERSITY

Councillors discussed the recent pollution incident in the River Weaver. Cllr Dobson advised that Cheshire East Council confirmed that it was not their responsibility to prosecute for such incident and this was the remit of the Environment Agency.

A discussion ensued regarding undertaking regular river water samples, and the Clerk was asked to ascertain the cost of obtaining such kits.

It was confirmed that the fly tipping along Paradise Lane had been removed. It was essential that instances of fly tipping were reported to Cheshire East Council via their web portal.
